ABOUT THIS REPORT

Our 2023 Integrated Report is the outcome of an all-inclusive reporting process that is governed by the Board of Directors and led by the Executive Committee (Exco). Integrated thinking enables us to create and preserve value to the benefit of individuals, communities and businesses, as well as the RES Corporation.

The report provides stakeholders with a balanced and integrated view of the Corporation's ongoing abilities and challenges in the short, medium and long term.

Reporting period

This is the 12th edition of our Integrated Report, a document that is published annually. It covers the period from 1 April 2022 to 31 March 2023 and focuses on the Corporation's operations, performance, issues, relationships and engagements over the past year.

Scope and Boundary

The scope and boundary of the report remain unchanged from the previous year, and the identified material issues are reported on, with the focus on the six capitals outlined

in the Value Reporting Foundation (VRF) Integrated Reporting Framework. The report incorporates the principles as described in the King IV Code on Corporate Governance (King IV).

Unless otherwise stated, data includes all entities covered by the Corporation's financial statements. All reported information is current as at 31 March 2023, unless otherwise indicated. The report has been prepared in collaboration with external and independent sustainability specialists. It has been reviewed by the Corporation's Executive Committee (Exco) and SNG Grant Thornton, and approved by the Board of Directors.

2.1 WHO WE ARE

Highlights

The Royal Eswatini Sugar Corporation Limited (RES Corporation), located in the north-eastern lowveld of Eswatini is one of the largest companies in the country. The Corporation is also the largest company listed on the Eswatini Stock Exchange with reference to market capitilisation, with interests in sugar cane farming and manufacturing of sugar and ethanol for sale in domestic, regional, and international markets.

The company employs more than 4 000 people and produces approximately two-thirds of the country's sugar as well as 35.3 million litres of ethanol a year. RES manages its own sugar cane on two estates and some farms on behalf of third parties. RES grows approximately 22 500 ha of irrigated sugarcane on its own two estates and manages 1 870 ha on behalf of third parties. In addition to its own sugarcane supply, the company buys in cane from Outgrowers and in a normal year

produces some 470 000 tonnes of sugar. More than 2 500 families in the community are involved in cane production.

We produce high-grade ethanol which is sold to the beverage and pharmaceutical sectors. In addition, the company produces feints, which are used to manufacture methylated spirits and bio gels. It also produces concentrated molasses stillage, which is used to produce liquid fertilisers.

RES provides housing and all infrastructure for its employees and dependents. It is also involved in cattle and ecotourism.

RES operates in a very dynamic environment where the national, regional and international situation must be continuously analysed and taken into account to ensure our sustainability.


2.4 OUR OPERATING ENVIRONMENT

New dynamics include:

- The continuing impact of the crisis in Ukraine on the international commodity markets and in turn the rising costs of a wide range of goods and services;
- The prolonged, but gradually subsiding effect of the Covid-19 pandemic on international, regional and domestic economies and markets;
- The volatile global oil and gas markets and the price of energy;
- The very real prospect of Eskom restricting electricity sales to Eswatini post October 2025 and effecting significant year-on-year energy tariff increases;
- Climate change and its impact nationally, regionally and globally;
- Local climatic trends: for example, intense storms and excessive rainfall (in and out of season), and drought in Eswatini (and its impact on irrigation water supply, cane yields and crop length);
- Volatile sugar markets and prices, in light of the above;
- The continuing health debate around sugar globally and the prospect of wider and deeper imposition of sugar taxes in South Africa;
- Resulting from COP 26 and 27, the more urgent move towards the green agenda and renewable energy, and how it will play out both in Africa and globally;
- The need to balance horizontal and vertical cane expansion at RES, in line with capital constraints, financial performance and other factors; and
- The occasional unrest in the Kingdom.

Sugar Market Review

World market sugar prices (the New York No. 11 contract) have continued to rise recently as supply side tightness becomes apparent. With crop estimates in some northern hemisphere producers (China, Pakistan, Thailand and Mexico) falling, and no further exports from India expected, the market is placing more reliance on Brazil, where there are concerns about logistical constraints affecting exports. From a trading perspective, the revision to production estimates suggests a very tight balance for 2023 in both the raw and white sugar markets.

In contrast to a late 2022 prediction of a global surplus for 2022/23 (October/September) of about 4 million tonnes, analysts are now looking at a smaller surplus of only 1 million tonnes. Furthermore, a modest surplus of only 1-2 million tonnes is being forecast for 2023/24. Other factors at play are the prevailing concerns about the world economy, a strong US Dollar and weak Brazilian Real, high oil and energy prices - impacting on the value of bagasse and ethanol, Indian ethanol policy and uncertainty over prospects for re-imposition of Brazilian fuel taxes - which would in turn impact on ethanol parity. The changing market dynamics, lower availability of refined sugar in the market and increased energy costs have also impacted on the white sugar premium.

Although Africa is clearly affected by global sugar trends, there are also different drivers and dynamics at play on the continent: notably population increase, higher than world average sugar consumption growth and the transition from direct to indirect consumption of sugar in manufactured products as economies develop. Prices in such markets are at a premium to world market values. Eswatini has preferential access into markets in the region with Kenya being the preferred outlet as it offers a good premium over world market prices. However, competition in the Kenyan market is intensifying and other outlets are also being sought.

The SACU market continues to absorb the greatest volume of Eswatini sugar, offers the best price prospects – which increase in line with South Africa's inflation – and is characterised by modest growth.

In summary, world sugar market and price prospects for 2023/24 look promising with world production, particularly in the northern hemisphere being impacted by weather events and global

consumption reaching an all-time high. As usual much will depend upon the size of the forthcoming 2023/24 crops in Brazil and India. Ongoing tightness in the global market will support international benchmark prices for both whites and raws, which will in turn boost prospects in domestic and regional markets.

Ethanol markets

Due to the high degree of volatility in the ethanol market, RES has adopted a strategy of maintaining flexibility in order to facilitate quick responses to erratic market swings. The intention is to continue this approach while also looking at diversifying the market base to sell not only in various geographic markets but also to be able to play in various new product segments. The prospect of bottling liquor for the retail sector, which is at an advanced stage of analysis, is one such example. Supplying fuel grade ethanol when an Eswatini blending mandate comes into effect is also being considered.

Energy

The Kingdom currently imports in excess of 75% of its electricity requirements, with the majority sourced from Eskom under an existing Power Purchase Agreement (PPA) with the Eswatini Electricity Company (EEC) that expires in October 2025. RES, along with its growers, is currently reliant on "imported" grid power for its irrigation requirements. There is a real risk that, after October 2025, when the current agreement expires, Eskom could restrict electricity sales to Eswatini, something that has serious implications for RES. In any event, the cost of imported power will likely significantly increase year on year.

Outlook

Looking ahead, LMC International, a leading industry analyst, is predicting that by the mid to late 2020's, new capacity will be required to meet the growth in global consumption of sugar, which they estimate at about 1% per year. Not only will an increase in prices be necessary to stimulate the required investment but Brazil's path towards greater use of ethanol (via its Renovabio initiative) and other factors could potentially open the door for others, such as Eswatini, to produce sugar for the growing world market. Such world market sales could prove attractive in times when EU demand for imported sugar and EU prices are both low. Moreover, Eswatini can enjoy a modest regional/location premium on such world market sales.

Despite the current climate-related and other difficulties which it is facing, the Eswatini sugar industry, and RES in particular, has sound fundamentals. The industry also has high levels of technical performance and, in a normal season, low unit costs relative to several other regional players. It is well placed for exports, has access to a protected domestic market, maintains membership of multiple regional trade agreements and has built a good reputation as a consistently reliable supplier to the EU. It also has the ability to competitively add value and switch markets in pursuit of value and margin.

Eswatini's strategy remains in place and focuses on maximising sales to the highest priced markets, subject to quotas or other restrictions, with the focus on direct consumption sugars. The markets for Eswatini Sugar continue to be SACU, USA under the tariff rate quota and East Africa. Direct consumption bagged sugar is sold to the EU and African regional markets. Any further (bulk) sales are made into the EU or World markets.

3.1 MESSAGE FROM THE CHAIRMAN

- DR A.T. Dlamini

The 2022/23 operating environment was extremely challenging, characterised by continued negative impacts from climate change on our operations and the repercussions of the Russia/ Ukraine conflict on our costs.

Our financial performance was significantly lower than last year, with total comprehensive income shedding 41% and dropping to E179 million (2022: 303 million). Nevertheless, the business continued to add value to its shareholders, with a total dividend declaration of 53.5 cents per share (2022: 192.9 cents per share).



Unit production costs remained under pressure, driven by the lower climate and pest and disease-affected volumes and exacerbated by the impact of the Russia-Ukraine war on fertiliser and fuel prices.

Optimisation of assets

Capital allocation was directed at expanding existing business operations and investing in value-creating growth opportunities such as the 850 ha of additional land under cane and the continuing upgrade of Mhlume factory.

The company retained its ISO certification on the 9001, 18001 and 45001 standards.

Board performance

The Board continued to execute its duties in accordance with the principles of King IV and other governance best practice. These efforts have delivered value not only to shareholders but also to our broad range of stakeholders.

The Board continued to increase its role in integrating reporting and implementing sustainability, Environmental Social and Governance (ESG) policies.

Our Board has played a critical role in supporting the strategic direction of RES, providing oversight on the implementation of our strategy, cost containment and capital allocations for much-needed investments in value-creating growth opportunities despite extremely constrained operating conditions.

The Audit Committee played a critical role in overseeing financial risk management, especially in view of the challenging financial environment that was experienced.

The Risk, Social and Ethics Committee continued to monitor the management of ethics, fraud, corruption, safety and health within the workplace. In addition, the committee focused on IT governance, and on activities pertaining to RES meeting its obligations and responsibilities related to ESG.

The Remuneration Committee concentrated on building a talent pipeline to attract and retain key talent.

Highlights

- During the year under review, the Board continued to support the strategic direction of the organisation, providing oversight on strategy implementation, while assuming full accountability for good governance.
- Emphasis was placed on continued capacity building amidst a turbulent business environment.
- Significant attention was given to talent management and the importance of succession planning and retention of critical expatriate skills that are essential for implementing our strategy.
- Successful oversight of corporate social citizenship through RES's investment in education, health, sports and cultural activities for the benefit of our surrounding communities and society at large.

Technology

I am pleased to note that the S/4Hana ERP was kicked off during this year and will be implemented in a phased approach over the next few years. The project will raise the bar for RES's digital footprint, with benefits in the form of work efficiency, cheaper IT running costs, and data analysis that is expected to improve operational efficiencies. This will undoubtedly contribute largely to our strategy of cost containment and optimising efficiency.

Future outlook

It is becoming increasingly clear that climate change is probably one of the most critical global challenges that will have a long-term impact on businesses and humankind. In the section, "The Impacts of Climate Change" (see pages 38-39), the effects of climate change on various components of the business are explained in more detail. We will have to develop an encompassing response strategy to mitigate these impacts.

We are committed to integrating ESG matters into our business decisions, company strategy, reporting and operations going forward, and this will be an area we will expand on in future reports.

Acknowledgments

My sincere appreciation goes to my fellow Board members and RES management and employees for their commitment and the manner in which they have handled the hardships the company has faced during the year. Together, we have weathered the storm.

Special thanks go to Mr I Ahmed, who retired as a Board member in March 2023. We will miss your commitment shown over the years that you served on the Board. A hearty word of welcome to Mr Sylva Okolieaboh, our new Board member. We are looking forward to your inputs and participation in our deliberations.

Our sympathy goes to the family of Mr Andrew Hlatshwayo, our long-serving Tax Financial Manager who passed away in October 2022.

RES remains committed to creating and maintaining sustainable and mutually beneficial relationships with all our stakeholders. Thank you to our shareholders, suppliers, the Government, and all other stakeholders for your continuing belief in and commitment to RES.

3.2 MESSAGE FROM THE MANAGING DIRECTOR

2022/23 was a challenging year for RES, characterised by extreme weather conditions such as heavy rain, storms and strong winds. Consequently, we failed to achieve our expected cane yield of 109.9 tonnes cane per hectare (tch), with an achievement of 96.4 tch against 93.7 tch for 2021/22. Sugar production was 1% lower compared to the previous year. The total area affected by storms was 15 392 ha, with 5 301 ha of cane severely lodged. National social issues resulted in stay-aways, which also impacted on our production.

Due to the extreme weather conditions, our factories operated under inefficient stop-and-start conditions, resulting in the season extending into the rainy season, typically reserved for our annual off-crop maintenance programme.

Our financial performance was thus disappointing, with total comprehensive income decreasing by 41% from E303 million for 2021/22 to E179 million for 2022/23.

Sugar futures continue to rise and suggest a tight balance for 2023 in both raw and white sugars with a small surplus of 1 million tonnes. A strong US Dollar and weak Real, high oil and energy prices and reimposition of Brazilian fuel taxes are affecting the ethanol parity pricing, which may result in increasing input costs in both field and factory. Sugar prices should rise towards the middle to end of the decade due to world production constraints.

The financial challenges facing one of our major competitors in the region can be both a blessing and a curse for RES as the competitor's drop in production, or even complete failure, could mean an opportunity for Eswatini to put more sugar into the South African market, but could also weaken the South African Sugar Industry, something that can pose an additional risk to RES. This is important in the context of the tariff for SACU because the sugar user's voice would become louder as the sugar industry's voice gets weaker. The sugar users will be pushing for cheaper sugar through the suspension of the tariff and thus easier access to world market sugar at world market prices.

RES operating strategy

Megatrends relevant to RES are the rise in water scarcity, the rise in energy volatility, increase in alternative/renewable energy demand, more natural disasters and increasing environmental regulations. We are responding to these and other megatrends through our specific Simama 20-25 initiatives, enterprise risk mitigation plans and other longer-term actions.

Although RES was experiencing difficult operating conditions, which resulted in sub-optimal performance, the fundamentals of the business are still strong. We are well placed to take advantage of the opportunities for energy and alcohol as well as reduced unit cost.

As part of our growth strategy we have, during the reporting period, acquired 35% of Enviro Applied Products (Pty) Ltd, which has boosted our investment portfolio.

Agriculture Operations

We completed the season on the 8th of February 2023 under extreme challenges (wet weather, arson attacks, industrial actions both internally and nationally etc.) compared to the normal seasons ending November to mid-December. Violent storms again extensively damaged the crop on the 26th and 29th of March, where a total area of 10 527.5 ha was affected, of which 689.0 ha were damaged by hail, 4 689.6 ha were damaged by hail and lodging, and 5 550.6 ha suffered lodging only. As a result, the cane yield estimates for the ensuing 2023/24 season were reduced from the original estimate of 94.8 tch to 92.6 tch.

Our cane yield for the 2022/23 season was also affected by severe incidents of pests and diseases; and the total area applied with pesticides increased by 58% from 15 051 ha to 23 868 ha.

The expectation is that the 2023/24 crop will be harvested at approximately 10.6 months, with the season ending in November, before the start of the rainy season. This will normalise the growth and harvest cycle. Consequently, the 2024/25 season yields are expected to be in line with our long-term average.

Expansion activities planned for 2023/24 cater for the completion of the development of 199.1 ha of new land. Our plans to convert other irrigation systems to drip at about 600 ha a year until 2033 remain in place, albeit with a holiday in 2023/24 following the adverse operating conditions, and thus curtailed cash flows. When complete, most of our cane should be under GPS-guided drip. These actions will pave the way for the introduction of mechanised harvesting in the future.

Our factories

Our sugar mills are generally self-sufficient as we use our sugarcane bagasse as fuel for the boiler. However, during heavy rains, we must supplement with coal or woodchips.

The future looks sustainable for the business. We are developing the necessary skills at both technical and management levels. Improving the plant performance by adding new equipment is key to our Simama 20-25 strategy, where sugar volumes are maximised while costs are minimised. In this regard, our efforts at continuously improving downtime and overall recoveries in our mills will continue to receive maximum focus.

Distillery and ethanol markets

The distillery was modified and upgraded during the year by changing its old distillation plant of 40 kilolitres/day (KL/day) capacity, to a new multi-pressure vacuum technology plant of 69 KL/day capacity, with an integrated anhydrous alcohol plant of 55 KL/day. The plant is a great energy saving initiative as the new plant now operates at 2.6 kg/litre steam consumption against 5.4 kg/litre steam consumption for the old plant. This upgrade resulted in a reduction in the unit cost of production per litre of ethanol and an increase in the profit margin.

Inconsistent power supply is still a problem, with approximately 500 hours of outage recorded. The distillery was also affected by inconsistent delivery and poor quality of molasses.

During the year, the corporation completed a study into the alcohol bottling and blending industry with a view to establish the possibility of venturing into this industry as part of our diversification initiatives. Further work is currently ongoing to develop the business case and identify the route to market. Different options are being considered to increase the income from the production of ethanol.

Human capital

We launched a Performance Management Review exercise which sought to review the performance philosophy and practices on how performance is managed by RES. The result showed that our performance practices are aligned to best practice.

Our Leadership Academy had another successful year with the intake close to 100 candidates across the 3 flagship programmes from the University of Stellenbosch Executive Development (USB-ED).

Energy self-sufficiency

The drive towards energy self-sufficiency and diversification through renewable and sustainable energy generation is at the heart of the RES Energy Master Plan. This Master Plan takes a 2-phase approach, first addressing the current energy security risk, and then aggressively expanding generation capacity to export into the national grid. This is based on the fact that the power purchase agreement between Eswatini and South Africa is coming up for renewal in 2025. RES is therefore moving towards renewable energy generation options, such as solar plants and new biomass boilers for high pressure steam and maximum electricity production so that we can be self-sufficient by 2026.

To mitigate the imminent energy security risk, in addition to optimising and maximising generation from existing capacity and planning for offcrop generation, RES is investing in a 10 MW Solar PV Project, to be developed at the Mhlume Sugar Estate. The project will be grid-tied, utilising ground-mounted single axis tracking structures.

Becoming a large-scale electricity producer in the next few years is very much in our sights. Although the existing Eswatini power purchase agreement with South Africa will be renewed in 2025, Eswatini's power supply will no longer be secured. This risk impacts directly on the sustainability of the RES business. We also hope to become a net exporter of power to the national grid in the longer term. Eswatini currently imports in the order of 75% of its electricity from Eskom.

There are also several opportunities for enhancing energy efficiency across RES's operations. Some form an integral part of the factory projects at Mhlume and Simunye, while others could potentially form part of a wider energy master plan.

Livestock and game

The ranch is approximately 19 000 ha and is rearing 1 996 head of cattle and 18 403 head of game as per the census conducted in October 2022. The breeds of cattle kept on the ranch are Red Brangus and Nguni. During September 2022 we had our first auction of livestock, which resulted in a 15% increase in revenue. At the butcheries, we changed the times of operation and undertook a rebranding exercise. These actions led to improved sales.

Growers

The replanting of 659 ha by the growers during the 2022/23 season will go a long way towards ensuring sustainable productivity. RES assists outgrowers through the provision of extension and pump maintenance services. This is strategically done to ensure that the outgrowers stay in business. Their sustainability is key to our own sustainability. The 5% upward review of transport subsidy for long-distance growers in Malkerns and Sidvokodvo that was granted during the year should ideally yield a slight improvement towards growers' sustainability and pave the way for positive engagements on the multiple matters that are still on the table with regards to the transformation of the industry. We ultimately need to realise that the existing Industry Agreement under which we operate, has become antiquated and needs to be updated for today's relevance, and more importantly, to reflect the business needs of the future. We shall continue to engage all stakeholders with the aim of gaining consensus on the matter.

Health and wellness

In order to increase access to health care, RES Clinics implemented the Over the Counter (OTC) medication sales project. This enables employees

and non-employees to purchase drugs from the Clinic using prescriptions, or to purchase without prescriptions for the medical drugs which qualify. The outcome will be an increase in the Clinic revenue and improved productivity by eliminating time off the estate in search of medications.

A baseline customer satisfaction survey to establish the current satisfaction levels and identify areas of improvement was conducted during the reporting period. Areas identified for improvement included: patient waiting time, need for clear instructions on how to take medications and explaining reasons for prescribing specific medications.

There was a slight increase in the number of RES employees on anti-retroviral treatment. About 99% of the employees on treatment are virally suppressed and healthy, thus HIV is no longer posing a threat to employee productivity.

E4.2 million was collected from all three company clinics in 2022/23. 50% of the revenue was collected from medical aid claims and 20% from cash-paying patients. Employees and their registered dependents received medical and wellness services worth E16.2 million between April 2022 to February 2023.

Safety statistics are worse than I would like, although we have turned the corner, and our injuries on duty (IODs) are dropping.

Stakeholder relations

For 2022/23, strategic focus was placed on neighbouring, or fence line communities. We aim to create and formalise engagement platforms with communities in order to inform the partnerships that will collectively address issues specific to the different areas. A community perception survey was deployed to assist in developing a community engagement strategy. Alongside that, a women empowerment initiative, community soccer sponsorships, traditional leaders' lunch with myself and senior management, and a community sanitation project were successfully carried out.

Notable outcomes during 2022/23 were the receptive nature and general cooperation of community leaders to RES engagements and the promotion of small businesses for local women through the construction of multiple market shelters across our communities.

For 2023/24, we plan to lock down a comprehensive community engagement strategy that will be a direct case for CSI initiatives, projects, and programmes as informed by the community perception survey report and validated by the community.

Corporate Social Responsibility (CSR)

The central idea of CSR is that corporate bodies have a responsibility to meet the needs of a wider group of its stakeholders than simply its shareholders (owners). Perceptions are that CSR, as an important instrument for successful business operations, provides an opportunity for business to look beyond narrow economic returns and become involved in the wider social and environmental concerns.

In our context, CSR can be viewed as treating the community of the Corporation ethically or in a responsible manner. This idea does not limit the benefits to the Corporation, but rather places the emphasis on the communities.

Outlook

This has again been a challenging year. Nevertheless, we continue implementing our strategy and I believe that our efforts will pay off in the end, starting with the coming year.

Social issues remain a concern. The prevailing socio-political instability in 2022/23 and prior resulted in damage to our crop and the interruption of our harvesting programme. Sadly, these issues may not end soon and easily, given their complexity.

We also continued to feel the negative impacts of climate change, which negatively affected our harvesting and crushing season, and subsequently our sugar production.

There are, however, also positive developments to report. The dams are full and we have sufficient water for our irrigation requirements. This, combined with improving crop practices, should see an improvement in production.

Our ethanol business is doing better than expected and shows promising signs of increasing contributions to our bottom line. I expect the general market price of sugar to be buoyant over the next few years and a weaker Lilangeni will benefit us.

We continue to implement measures to improve efficiencies to retain our position as one of the low-est-cost producers of sugar in the world, and we have earmarked E226 million for power security and efficiency projects to ensure sustainability in the financial years ahead.

I believe we are well placed for optimising exports and can quickly respond to opportunities as they arise. This is assisted by our reputation as a consistently reliable supplier to the EU and our ability to competitively add value and switch markets in pursuit of value and margin. Operating in a protected market and changes in the South African sugar industry further open up opportunities.

From our experiences in dealing with difficult circumstances over the past few years we have learnt to grow and flex our resilience muscle to weather these storms and come out stronger and more robust.

3.3 FINANCIAL OVERVIEW

In our 2022 Integrated Report, we indicated that 2022 had not been plain sailing. 2023 proved to be another year of challenges. Unusual winter rains, combined with high input costs due to the Russia/ Ukraine war collectively depressed our total comprehensive income from F303m in 2021/22 to F179m.

Similar to the prior year, the current year's crop was negatively affected by adverse climatic conditions, experienced as excessive winter rains, wind and hailstorms that damaged some 15 600 ha, of which 5 300 ha were severe. The impact of these events, operationally, was an extended season into February 2023, and cane and sugar production levels that were well below long term averages, with a ripple effect into the 2023/24 season, where the crop will be harvested at a non-optimal young age, as there is a need to realign the end of the harvest season to November of each year.

Further storms were experienced post-harvest, at the end of March 2023. This has downgraded the original yield expectations for the 2023/24 season and thus results in a negative impact on the year end valuation of standing cane at 31 March 2023 While we previously expressed our hope that the Russia/Ukraine conflict would be resolved quickly, it is disappointing that this did not materialise. As a result, we were plagued by steep increases in the cost of fuel, agrochemicals, process chemicals and steel, as part of global geopolitical inflation. All these factors combined resulted in reduced cash generation and a significantly lower profit level.

On the positive side, the dams are full, and we have sufficient water for irrigation. Also, the ethanol business did much better than expected and is showing good signs of increased profitability in the future.

Ongoing expansion

The Expansion drive continued with about 850 ha of new cane land that was developed as well as the continued 'Lego-style' upgrade of the Mhlume Mill. Debt funding of 75% was secured to enable the project to proceed.

The S/4Hana ERP project was kicked off in 2022/23 and will be implemented in a phased approach over the next few years. The project will raise the bar for RES's digital footprint with benefits in the form of work efficiency, cheaper IT running costs, and data analysis that is expected to improve operational efficiencies.

RES acquired a 35% interest in Enviro Applied Products (Pty) Limited. Enviro sources concentrated molasses stillage (CMS), a by-product of the ethanol production process, from RES, in terms of a long-term supply agreement, and blends it with other additives to produce a liquid fertiliser for

use in the agricultural industry. The acquisition is therefore a "downstream" investment opportunity, which will be adding more value to a by-product.

Numerous external factors have derailed performance, resulting in the crop being 12.3% lower than the budget but 4.6% higher than the previous year. This is the fourth year in a row that RES has seen below average cane and sugar production, despite an increase in the area under cane. Climate change, pests and disease, and to a lesser extent, social unrest, have been the main reasons for this reduction. Cane harvesting and milling operations in 2022/23 were inherently inefficient, due to the disruptive rains. Harvesting and mill processing costs were thus exceptionally high. With these volume and cost developments, our cost per tonne target is appreciably off track.

Our business model – to lower costs per tonne through increased volumes – remained unchanged and we continued with land expansion. Cash constraints compelled us to suspend several planned capital projects.

The business faced new significant climate change impacts during the year. The response to these impacts required dynamic forward-looking financial scenarios to enable appropriate decisions to be taken. New models were built that informed the daily decision-making process to enable RES to navigate the challenging times.

Priorities for 2023/24

- Bring to fruition the consolidation of two of our statutory companies, Mhlume Sugar Company and Simunye Sugar Estate into one single entity to achieve efficiencies across multiple spectrums of the business.
- To embrace the full implementation of the new S/4Hana Public Cloud-based ERP system and adopt SAP best practices for the benefit of the business.
- For ESG Reporting, we aim to optimise data collection and interpretation to enable the assessment of RES's key impacts as per the requirements of double materiality.

Outlook

Social unrest remains a threat to our operations and profitability. In response, our risk mitigation measures have added to the cost of doing business.

The Tongaat Hulett difficulties sent shock waves through the market with some negative sentiments towards the sugar sector. We are sensitive to the possible negative impacts of such sentiments in the area of raising finance. We, however, believe that RES is a solid business with sound principles.

Despite the negative impact of climate change effects occurring on a more frequent basis, the expectation, based on predictions of a possible return of El Niño in 2023, is that weather conditions in 2023/24 will be drier as compared to the current reporting period. The crop estimate for 2023/24 shows only a slight increase against 2022/23, due to the negative impact of having to harvest the crop at a younger age. This significantly curtails the Group cash generation base in an already difficult inflationary climate. Sugar production is expected to be higher due to better mill recoveries resulting from favourable weather that will eliminate the inefficiencies experienced in the current financial year. In 2023/24, the Group will pause its expansion drive with a view to resumption in 2024/25 when normal production levels are expected.

The sugar markets have been favourable over the past season. Due to the prevailing fundamentals, this state should hold in the next financial year. Loadshedding challenges in South Africa, however, have raised the risk profile of power supply security for the business. The group is therefore working towards the investment of some E200 million in the 2023/24 financial year, in an alternative energy project.

We believe that sugar consumption will continue to grow as the world population grows, incomes increase, and quality of life improves. Eswatini's good rainfall, climate, and soil give us a competitive advantage in terms of our cost structure. Efficient, low-cost operations will be crucial in this equation, and RES is well-positioned to fill the gaps as other players exit the market for alternative revenue sources.

Bringing in new technology and doing the necessary modifications are all part of the strategy to bring sustainability to the business by increasing efficiencies and reducing the cost of producing one bag of sugar.

3.4 OUR STRATEGY

Our strategy is a key part of our intellectual capital. It directs our investment and effort towards areas where it matters most for growth and sustainability of the company. We have crafted our five-year strategy and named it Simama 20-25.

The strategy is based on our aspiration to reduce the cost of producing one tonne of sugar by 20% by 2025. We will achieve this through meeting specific objectives in relation to efficiencies, productivity, and performance of all systems, processes, and human capital. We are aware that there will be many challenges, but we are up to the task to see to it that the strategy is successfully delivered.


Our strategy is supported by three pillars or themes that guide the RES management in selecting strategic initiatives:

- Cost optimisation we are focusing on unit cost reduction through efficient, cost-effective and innovative production of agricultural products using soil as our base asset.
- New products/markets we are pursuing new products and markets, where we are primarily looking at vertical integration from our existing products, while exploring other new product opportunities.

 Organisational culture - we aim to enhance our organisational culture based on strong motivation and innovation as we hold each other accountable to exceed individual and organisational goals.

The Board owns and is ultimately accountable for the RES strategy, while the Executive Committee is responsible for managing its execution. Business goals were the successful implementation of the revised list of initiatives in line with the framework. These were achieved with challenges in terms of costs and human capital availability. Change management functions were utilised to support implementation of the initiatives. A fair number of initiatives were postponed due to the revised cashflow management strategy.

Achievements against strategy

We have made progress on a number of fronts:

- Area under cane has increased by more than

 1 300 ha in the last two years, against a target of about 2 000 ha by 2025. This contributes to our strategic objective of increasing productivity and is in alignment with ongoing improvements of factory capacity, moving RES towards a lower unit cost of sugar production.
- Upgrading the distillation plant 1 (D1) did not only assist RES to realise production efficiencies but has also created possibilities for new products aligned with our markets strategic theme.
- We have taken the first strides towards the transformation of our performance culture through various organisational initiatives and the advancement of a change-agile mindset within RES.
- We are pursuing all viable possibilities for our diversification agenda through in-depth analysis of the economic environment. Obtaining full control of the former IYSIS business – now the Livestock and Game department, and 35% shareholding at Enviro Applied Products (Pty) Ltd are some of the examples underlining our intent to tap into new avenues for the sustainability of the company.

Looking forward

In line with our strategy, our focus will stay on our core business, which is producing sugar and related energy products taking the world market price into account.

It is becoming increasingly clear that climate change is probably one of the most critical global challenges that will have a long-term and lasting impact on businesses and humankind. We are proactively improving our understanding of this complex issue with a view to developing an encompassing response strategy to mitigate these impacts.

RES is committed to formally integrating Environmental, Social and Governance (ESG) matters into all business decisions, company strategy, reporting and operations going forward.



3.5 MATERIAL MATTERS

To help us deliver long-term value to our stakeholders, it is important for us to have a solid understanding of the sustainability issues that could impact our business.

To identify and evaluate these topics, we conduct sustainability-related materiality assessments that consider input from within our business and from our external stakeholders. Our process for determining these topics involves consultation, survey, analysis and validation and the link to our risk management process.

Material matters for RES are those concerns and good prospects that have a substantial impact on the sustainable capacity of the Corporation to create benefit for all stakeholders and influence strategy.

A risk profile is drawn up at the RES annual strategic planning session, usually held in November. These risks are cascaded through the organisation and mitigated at either corporate or operational level.

During the year under review, the Corporation continued to monitor internal and external developments that are likely to impact the achievement of strategic objectives and ensured the implementation of risk mitigation actions.



3.6 OUR BUSINESS MODEL

The business model summarises core and shared services for RES, cutting across organisational functions as follows:

- Agriculture
- Manufacturing
- Distillery
- Order-To-Cash (Marketing & Logistics)
- Plant Maintenance
- Procure-to-Pay (Procurement and Stores)
- Record-To-Report (Finance)
- Hire-To-Retire (HC)
- IT and Office of Strategy Management.


The core processes are:

- Inbound logistics (inputs of irrigation water, fertilizer, and related goods)
- Harvesting of cane
- Sugar production
- Production of ethanol
- Marketing and sale of ethanol.

The shared services processes support the core functions and ensure continuous efficient delivery of the RES mission and vision. The main revenue streams come from the sale of sugar and ethanol and outbound logistics. Additionally, revenue streams also come from the sale of citrus, carbon dioxide, concentrated molasses stillage (CMS), and various service-related revenues. The business model is a part of the Company's overall strategy as it is the nuts and bolts behind how RES plans to achieve its goals.

Extreme weather conditions, related to climate change, and unreliable Energy Supply remains in the top 3 risks which the Corporation has to manage in an integrated manner to ensure sustainability in the future.





4.3 IMPACT OF CLIMATE CHANGE ON OUR OPERATIONS

A combination of long-term change in the weather patterns worldwide (i.e., global climate change), caused by natural processes and anthropogenic factors, may result in major environmental issues that have affected and will continuously affect agriculture, including sugarcane production.

Climate change is expected to have important consequences for sugarcane production globally, marked by increases in the frequency and intensity of extreme environmental conditions. These conditions include severe drought, excessive rain, windstorms and changes to daily temperatures.

The impacts of climate change, as explained below, have been experienced by some of the RES entities and activities. Continuous research is part of our strategy to be able to understand how we can mitigate the impacts of climate change on our sugarcane production.

Finance

The business faced new significant climate change impacts during the year. The response to these impacts required new future-oriented scenarios to enable appropriate decisions to be taken.

One of the climate change impacts in 22/23 was the unprecedented winter rains from April through to June. Harvesting operations were significantly affected, such that cash generation was not sufficient and short-term financing needed to be sourced at short notice. Fortunately, our banking partners yielded to our call and enabled RES to continue to meet its financial obligations.

Agriculture

Due to changes in the weather, we experienced abnormal incidences of pests and diseases, with new pests and diseases discovered in the region. Crop damage from violent hailstorms resulted in cane lodging, breaking of cane stalks, high Eldana infestation levels, soil erosion, soil nutrient losses and destruction of infield infrastructure and access crossings. All these factors culminated in very low yields and increased operating costs for the season.

Water

The extreme wet weather experienced during the 2022/23 season characterized by frequent heavy storms and above normal rainfall is attributed to climate change impacts. This has both positive and negative consequences to our activities and outputs.

Negative effects – cane harvesting was severely affected, with above-normal burn-to-crush times in the 2022/23 season. Consequently, the crushing season extended past the optimal nine months into February. Sugar recoveries in the mills dropped markedly, reducing revenue. The impact of the season extension extends into the 2023/24 season, where yields will be low due to the non-optimal harvesting of cane at a young age as the crushing season is re-aligned to end in November/ December. The completion of projects was compromised while infrastructure damages were experienced, requiring costly maintenance.

Positive effects – the above normal rainfall enabled water harvesting and ensured adequate water for the crop going forward.

Although not experienced in the 2022/23 season, frequent and severe droughts are also a result of climate change and result in water scarcity affecting water supply for optimum irrigation of the crop.

Livestock and game

In livestock and game operations, the impact of climate change is immense, particularly due to the erratic rainfall received in 2022/23. In December we received 93 mm, at a time of the year when most grasses are at flowering stage, and for the better part of the month we received a heat wave. This went on even in January, when we received 84 mm in two weeks and the rest of the weeks it was a heat wave. This disturbs the growing stage of the grasses, hence affecting the net above ground biomass. In February we received 351 mm which fell in two weeks and caused a lot of damage on the rangelands with soil erosion

Growers

The impacts on the activities of our growers were similar to our own agriculture section, being storms, hailstorm, new pests and diseases and changes in the weather pattern. These resulted in increased harvesting costs due to wet harvesting, and the leaching of important nutrients beyond the root zone. Another issue related to climate change was the extension of the milling season which then means in the 2023/24 season, we will be harvesting cane younger than 12 months.

Human Resources

The direct impact of climate change is limited but indirectly it is significant because it can affect budget availability for implementing the initiatives. It can also affect the availability of employees to participate in such initiatives, as well as increased ad hoc recruitment of casuals for cane extraction from wet fields.

The adverse impact of climate change which has an impact on the Corporation's overall bottom line, makes the cost of living salary adjustment negotiation process challenging.

Supply chain /procurement

Excessive rainfall resulted in interruptions in the delivery of coal and woodchips. There is no delivery of coal when the coal mines are flooded, and the harvesting of timber is significantly impacted when there is excessive rain, which results in poor delivery of woodchips.

Stakeholder relations/CSI

Due to climate change, we had an increase in disaster relief requests from victims of natural disasters.

Factories

A sugar mill does not like a wet season. High mud levels in cane cause uncontrollable losses of product. Slow cane supply results in excessive fuel usage and escalates input costs.

Distillery

The impact of climate change on alcohol production depends on the events. The 2022/23 inefficient wet harvesting meant a degradation of the cane crop, affecting sugar recoveries. Molasses production was thus higher, which bodes well for the distillery. However, it is more economical to extract value from sugar production and sales than from the production and sale of alcohol. Wet conditions may also disrupt the availability of molasses to the ethanol plants due to reduced or interrupted cane supply into the sugar mills.

Property

Climate change comes with sporadic weather patterns, including hailstorms and heavy rains causing costly and major damages to residential buildings, roads, and other infrastructure. Damage to roofs and the flooding of houses that are in low-lying areas in the villages in turn result in housing challenges, with tenants having to be relocated.

4.4 ENERGY SECURITY AND DIVERSIFICATION

The drive towards energy self-sufficiency and diversification through renewable and sustainable energy generation is at the heart of the RES Energy Master Plan. This Master Plan takes a 2-phase approach, first addressing the current energy security risk, and then exploring the potential to expand generation capacity to export into the national grid.

To mitigate the imminent energy security risk, in addition to optimising and maximising generation from existing capacity and planning for offcrop generation, RES is investing in a 10 MW Solar PV Project to be developed at the Mhlume Sugar Estate.

Mhlume 10 MW Solar PV Project

A feasibility study for the project was undertaken in the 2022/23 financial year, with the project approved by the RES Board in March 2023.

The project, to be developed through an Engineering Procurement and Construction (EPC) contract, will be grid-tied, utilising ground-mounted single axis tracking structures. It will have a 12.94 MWdc capacity, with a total guaranteed point of connection capacity (POC) of 10 MWac, and an annual energy generation of more than 22 GWh.

The procurement of Owners Engineering services and an EPC Contractor Service will be undertaken in the beginning of the 2023/24 financial year. Works on the ground are planned to start in January 2024, with a scheduled completion and commercial operation in December 2024.

Power Generation for Export

Whilst the 10MW Solar PV will mitigate against the energy security risk, it will not result in self-sufficiency. Hence the need for a large-scale power project to make the required step change to meet all RES power requirements, and further generate in excess of 20MW of surplus power for export.

Due to the huge capital requirements for the envisaged large-scale power project, RES intends to partner with other investors and develop the project(s) through Special Purpose Vehicles (SPVs).

The selection process for the development partner was kick-started in November 2022, with RES sending out a Request for Proposal (RFP) to identify and select a reputable development partner. This process should conclude in the 2023/24 financial year and have the SPV registered and ready to start the required feasibility studies.

5.1 FINANCIAL CAPITAL

Financial capital is broadly understood as the pool of funds available to an organization. This includes both debt and equity finance. This description of financial capital focuses on the source of funds, rather than its application, which results in the acquisition of manufactured or other forms of capital.

RES continually seeks to optimise its capital through the appropriate mix of debt and equity. In doing so, we recognise the business's various risks, as detailed in section 4.

The current funding policy provides a 70-75% debt funding range for growth projects. This is complemented by a dividend policy of 50% of profit after tax.

Working capital facilities are put in place for seasonal cash requirements. Typical of a sugar operation in Eswatini, sugar receipts stop in December and resume in April when the new milling season commences.

The expansion drive continued in 2022/23 with around 850 ha of new cane area developed. Upgrading the Mhlume Factory also continued,

although various works were deferred to the coming seasons owing to the weaker cash position during the financial year.

In February 2023, RES acquired a 35% stake in Enviro Applied Products (Pty) Limited.

Debt funding of 75% was secured for the capital incurred on the growth initiative described above.

The unusually wet winter affected our ability to harvest cane and turn it into sugar. Cash flows for the period April 2022 to July 2023 were significantly curtailed. Fortunately, with a good understanding of the agricultural environment, our banking partners stepped in and availed short-term credit facilities that ensured that we could meet all our financial commitments.

We also made a deliberate effort to engage our various stakeholders, which included shareholders, assurance providers, long-term debt partners, and the tax authorities, regarding the unique negative impact on the business of the climatic developments.

The business began migrating from the current ERP setup to the cloud-based S/4HANA instance. This project will set a new standard for RES's digital footprint. Through this project, we are earmarking increased productivity at work, lower IT operating expenses, and increased operational efficiencies through data analysis. The migration will take place over a few years to manage cash outflows and execute the project in smaller components with a view to improved implementation.



5.2 HUMAN CAPITAL

Our human capital management efforts rest on six pillars and underpin the RES corporate strategy. A process to shift the organisational culture in order to drive higher performance within the organisation began in 2022/23. This process was coupled with a focus on cultivating future-fit capabilities and skills to address diversity and accommodate a flexible portfolio at corporate level. This then meant we had to cover issues of governance, manpower planning, quality-health management and implement SAP Employee Central for a complete view of the Human Capital Management Division.

Size of workforce

A total of 4 206 employees were under the RES employ at year-end, compared to 4 593 recorded at the same time in 2021/22. In the year under reporting, 1809 were permanents - including fixedterm employees - compared to 1 864 recorded in 2021/22, while 2 372 were seasonal employees, compared to the 2 729 recorded at the same time last year. Although the number of seasonal employees fluctuates according to operational requirements, this year, the ongoing expansion of land-under cane at Homestead saw a steady increase in the number of seasonal employees.

Staff turnover

A total of 22 permanent employees resigned from RES employment this year. 5 were from middle management, and 3 came from T16 and above. These figures show a healthy turnover rate, which is substantially below the universal 5% threshold.

Manpower costs

The total Manpower cost stood at E954 million at year-end (2022: E883 million), showing an E73 million increase from last year. Discretionary overtime exceeded budget by E27m due to the above-normal breakdowns experienced in the plant.


Overtime

Nearly E110 million has been spent on overtime, against a budget of E83 million. In the majority of cases, the E27 million over-expenditure arose from the several factories' start-up teething problem, as well as breakdowns experienced during the difficult milling season this year which resulted in higher lost time available (LTA). As a result, the overtime expenditure was 2% above the standard 10% of the total wage bill.

Short-term incentive bonus

A crucial part of our employee value package, the short-term incentive (STI) incentive supports our initiatives to change the organizational culture by fostering a high-performance environment.

For the financial year 2022/23, RES made a profit after tax (PAT) of E178.5 million and a return on net assets (RONA) of 6.8%. This is less than the E302.6 million PAT and 12.5% RONA for 2021/22. The Board of Directors has authorized paying the computed STI bonus to qualifying workers, in accordance with the STI thresholds.







Human Capital - Operations

Learning and Talent Development

The department is responsible for the implementation of the learning and talent strategies for the organisation to meet its business and strategic objectives.

This includes creating an enabling culture, and implementing best practices of staff development, organisational management, and talent management (assessment tools management, leadership, technical/functional, personal effectiveness development, succession planning, and performance management systems).

During the reporting period, the following initiatives were implemented:

Cultivating Future-fit Capabilities and Skills

- Each leader should prepare leaders for the future: Talent Reviews were conducted, covering more than 600 employees in T10 and above. The data from the reviews was utilised to complete individual development plans for the employees and also to inform the review of succession plans.
- Performance Management: We introduced measuring employees' performance on the RES values, as part of ongoing performance conversations. This is aimed at producing a positive shift in the culture at RES.

The setup for the soon-to-be-launched technical school has been finalised and RES is ready to begin providing skills to a workforce that will be able to tackle industry requirements.

Technical and leadership development: About E20 million, against a full-year budget of E17 million, was spent in this area of development. The total of employees physically trained by year-end was 2 730, against the planned. 2 755. The variance was for mandatory factory compliance training, in preparation for the food safety audit. One of the critical interventions deployed was the Executive Coaching Programme for some senior managers and Coaching for Exceptional Performance.

Manpower Planning

During the year, we commissioned a project to assess whether RES had the requisite skills to deliver on its strategic needs. Along with the review, we formulated an enhanced – current and future – technical and behavioural skills catalogue, with a priority listing across all divisions.

Employee Relations

The department is responsible for maintaining harmonious industrial relations at the workplace. This is achieved through the development and implementation of the employment relations strategy, practices and processes, which support the business strategy, while maintaining workplace harmony. This includes among others:

- Developing employment industrial relations skills among line managers and supervisors.
- Facilitation of corporate negotiations and consultation forums to enhance dispute resolution, underpinned by win-win outcomes.
- Keeping collective agreements current and ensuring that all internal stakeholders are fully conversant with the provisions.
- Ensuring that workplace forums take place, are effective, and that insights are drawn from the issues to inform critical interventions.

In the reporting period, the Corporation invested in capacity-building workshops in which 96% of senior management were trained on performance management.

The Medical and Wellness department is responsible for providing primary health care services to the employees, contractors and members of the communities in general.

In order to increase access to healthcare, RES Clinics implemented the Over the Counter (OTC) medication sales project during the 2022/23 reporting period. This enables employees and non-employees to purchase drugs from the Clinic using prescriptions, or buy without prescriptions – for those medical drugs that qualify. This will increase Clinic revenue as well.

We also enabled electronic submission of medical-aid claims by RES Clinics – previously the Clinics were submitting claims manually to medical aid companies. This was inefficient and resulted in unpaid claims, to the detriment of the Clinics.

For the reporting period, the goals and targets for the Medical and Wellness Department were the following:

 Improve customer satisfaction – the main activity was the baseline customer satisfaction survey. The survey indicated areas of improvement in patient waiting time, clarity of instructions on how to take medications, explaining reasons for prescribing specific medications and improvement in staff behaviour.


- 2. Improve the quality of Primary healthcare services offered at the RES Clinics.
- 3. Health education and promotion according to the annual Health Education schedule.
- Provide psychosocial services to employees, their dependents and members of the community.
- Recover at least E3.6 million from medical aid, third parties and private patients.
- 6. Occupational health services:
 - a) Perform routine medical examinations on 100% of all scheduled Periodic Occupational medical examinations according to the defined Occupational Risk Exposure.
 - Manage all cases of Occupationally acquired diseases and disability according to national legislation and company policies.


There was a slight increase in the number of RES employees on anti-retroviral treatment. 99% of the employees on treatment are virally suppressed and healthy, thus HIV is no longer posing a threat to employee productivity.


Upper respiratory tract infections are the third most common condition for which employees are booked off sick.

About 21 cases of Covid-19 were reported among the RES employees and dependents, and all had mild symptoms.

E4.2 million was collected from all three company Clinics in 2022/23. About 50% of the revenue was collected from medical-aid claims, and 20% was from cash-paying patients. Employees and their registered dependents received medical and wellness services worth E16.2 million between April 2022 and February 2023.







Sick leave

The leading contributors to sick leave days issued to employees are injuries classified as sprains, fractures, and soft tissue damage. These mainly originate from recreational activities away from work, but they drive up sick leave as they take longer to recover.

We have had to drive awareness campaigns on hygiene as gastrointestinal-related conditions are also among the leading contributors, mainly from diarrhea in the estate villages.

Another concern is the emergence of acute stress disorder, an indicator of a possible strain to employees from either work or social problems or a combination. We are, on an ongoing basis, making employees more aware of mental health conditions which need professional intervention.

Management of illness at work

A total of 39 employees have undergone the management-of-illness at work process during the 2022/23 financial year. Seven cases were from injury-on-duty. Those terminated on medical grounds are among the seasonal employees who had exhausted their sick leave and were still not fit to return to work. It is encouraging to see that about 33% of employees with disability cases were able to return to work. This is attributed to a robust rehabilitation process that involves physiotherapy for employees.

The challenges we encountered included:

- 1. Increasing costs of drugs and equipment.
- Some pharmaceutical drugs were out of stock due to rationing in South Africa and the political unrest in Eswatini.
- Occupational Health nurses are a scarce resource, and the company has been having challenges in recruiting suitably qualified nurses in this category.
- The civil unrest caused some patients on chronic medications, such as anti-retroviral, anti-TB, anti-diabetes and anti-hypertension to go without medication.

We continued to support the business with excellent system uptime while implementing new value-added projects. Part of this is the uplifting of skills within the department. For one of the interventions, we introduced a coding challenge in which all IT staff had to develop a program that added value to the business using the SAP low code cloud function. Our system uptime was more than 99.9% during the year.

New initiatives during the 2022/23 reporting period included the following:

- 1. Success Factors: We migrated the human capital management (HCM) function from SAP ECC to Success Factors Employee central.
- 2. A digital adoption support system was introduced to support the use of SAP.
- 3. Fleet Management system: We implemented a new system to monitor the RES vehicles, this integrates to the Fuel system and SAP to better manage the usage of our fleet assets.

The RES digital journey was kickstarted with the migration of the internally managed SAP ECC system to the SAP S/4HANA public cloud. We have followed the Mission Led Team approach and have successfully migrated the Simunye Fleet workshop to S/4HANA. We have started planning the roll out to Agriculture, which will go-live in 2023/24.


We also implemented the preventive approach in managing Aphid attacks on the crop, and through

this increased effort, we reduced the pest threat. The bulk supply of Agrochemicals in the limited storage facilities was maximised to ensure timely application in the fields.

Crop Performance

The crop for 2022/23 marked the fourth year of performance being well below our long-term achievement levels. Climate change continues to be the chief instigator of this trend. This year's harvest season exceeded the optimal cut-off of early December, with the last field being delivered to the mill in the first week of February 2023. Excessive winter and summer rains were the architects of this development. Sucrose % was lower than for the previous year, while sucrose yield was marginally better. This is depicted in Figures 15 and 16.




Low Radiation: Figure 17 compares radiation against the LTM throughout the season. The total radiation received in the summer months (Sep -Feb) was below the LTM. Therefore, the crop could not grow optimally during this critical period. However, the total radiation received in the summer months was comparable to the 2021/22 season.

Excessive rainfall and high rain days in the summer months: Figure 18 shows the monthly rainfall received and rain days against the LTM. The results show that the total rainfall received in the winter and summer months was significantly higher than the LTM, with prolonged rain days. The combination of the increased rain days, excessive rainfall, and below LTM radiation subjected the crop to prolonged waterlogging conditions with no adequate sunshine - conditions which are not conducive for optimal crop growth.

Severe Cane Lodging: Cane lodging was experienced across the estate, where a total area of 15 392 ha was affected, with a net area of 5 301 ha severely lodged. The reduction in yield was caused mainly by the following:

- The side shooting of cane stalks which retards growth,
- Reduction in plant population from dead stalks, which are cane stalks that were broken during the storm,
- · Depending on the crop stage and severity of the lodging, most of the cane stalks were not exposed to the sunshine for optimal growth, and
- Increased Eldana infestation levels The cane lodging and excessive drying-off of the cane renders the stalks vulnerable to Eldana infestation, resulting in reduced yields and cane quality.




Pests and Disease Outbreak: The effects of the aphids and thrips on the crop were evident even this season, though not as severe as the last season. This is due to better chemical control. The total area applied with pesticides to control these pests increased by 58.5% from 15 051.7 ha last season to 23 868.4 ha this season. Previous SASRI publications indicated potential yield losses of up to 20% from these pests. Other factors contributing to the low cane quality include cane lodging on the early cuts and the early rains received in April 2022.


Burn-to-crush hours: Harvesting activities fall under agriculture. Figure 19 shows the monthly burn-to-crush hours for the 2022/23 season. Figure 20 analyses the unprecedented above-normal rainfall this winter season (April to June 2022). A total of 201 mm of rain was received against the LTM of 71 mm in the three months. This resulted in wet infield conditions, resulting in delays in harvesting and compromising the infield haulage operations. As a result, the total cane delivered in the three months was 49.9% below budget at 420 076 tons against 838 813 tons.

The period between November and February was also extensively wet (924mm at Mhlume and 715.3mm at Simunye). Again, harvesting operations were significantly curtailed. In February 2023 alone, the burn-to-crush delay shot to about 170 hours due to the significant rainfall received, which was, on average, above 500 mm.

The impact of these long times is degradation in cane quality and will be revealed in a lower sucrose pol % and adverse sugar recoveries in the sugar mills. Harvesting costs increased significantly, while mill processing costs also shot up.

The burn-to-crush times were also affected by two separate events. Firstly, during the latter part of the season, two illegal cane cutter strikes were experienced, which we assessed as being politically influenced. The cane cutters' strike lasted for a week. Secondly, there was a period whereby fuel became scarce, affecting our cane haulage contractors.

The burn-to-crush hours for the current season were thus highest in the last five years.

March 2023 Storm damage:

Two violent rainstorms were experienced across the estates towards the end of March 2023, where a total area of 10 527.5 ha was affected. Of this area, 689.2 ha were severely damaged by hail. Learning from our experiences in the 2022/23 season, the cane from the severely affected area will be prioritised for harvest in the 2023/24 season to mitigate further loss in yield and quality. This mitigation will result in a change in the harvest program.

Progress on growth strategy

As part of our expansion drive, new cane land totaling 832.6 ha was planted during 2022/23, 441.8 ha at Homestead and 390.8 ha at Ekuthuleni, against a target of 1 000 ha. The target could not be achieved because of the excessive rainfall received late in the season.

Embedded in our strategy is the conversion of 600 ha annually from other systems of irrigation to sub-surface drip irrigation systems. The objective is to increase yield and save water. However, drip conversion was suspended in both the current and previous seasons because of the lower cash generation of the business due to adverse crop performances.

Other developments during the 2022/23 season

Fatal Bus Accident: There was a deadly accident on a contractor's bus ferrying cane cutters to work, in which seven cane cutters lost their lives. The bus failed to drive up a steep road after crossing a narrow bridge and thus reversed into the river.

Arson Fires: The season was characterized by

rampant cane arson, affecting the daily harvesting plan. Fortunately, the illegally torched fields were dry fields that were almost due for harvesting.

Looking Ahead

The 2023/24 season is expected to be only slightly better than the 2022/23 season. The two storm events in March 2023, affecting almost 48% of estate cane, will again depress yields. Weather predictions point to a dry season with a general consensus amongst weather forecasters that the region will enter the El Niño cycle. On the upside, our dams are full, meaning the crop for future seasons will not be stressed. In the absence of significant and adverse exogenous events, we expect to return to our normal production levels in the 2024/25 season.



Water




Water is a critical resource for sustainable growth of sugarcane and good quality products, therefore the supply of water to support cane growing operations must be managed optimally. The design and installation of irrigation systems, as well as the maintenance of the irrigation infrastructure is core to ensure healthy crops.

During 2022/23 we managed to construct bulk water and irrigation infrastructure to enable the planting of 832.6 ha of new cane at Homestead and Ekuthuleni farms. 27% savings in water was achieved compared to budget, as a result of efficient water use and also taking advantage of the above-normal rainfall received during the season.

New developments during the 2022/23 reporting period

We continued with the strategic focus on increasing water storage capacity to enable harvesting and storing of more water to increase assurance of supply and to drought-proof the area under cane.

- This project entails raising the Sand River Spillway by 0.6 metres and increasing the pump station capacity from 5.2 to 7m³/s. Funding for the work is coming directly from all Mhlume Water consumers. The first phase was completed in 2021/22 and saw the pipeline installation and the construction of a discharge chamber.
- During 2022/23, progress was made on the second phase of the Sand River project, in which the installation of two vertical turbine pumps and construction of a Pump sump were completed.
- The project's next phase entails the supply and installation of a Motor Control Center (MCC) with 4x variable speed drives, complete with all related electricals. This work is planned for implementation during 2023/24. It will mark the completion of the Sand River Pump Sta-



tion Upgrade, which will result in an increase in the water harvesting capacity of the Sand River system by 2.7 million cubic metres.

 The final phase of the project will entail the raising of the spillway crest by 0.6 metres to ultimately increase the capacity of the dam by 4 million cubic metres.

Challenges that hampered our activities during the reporting period included the wet weather, which affected progress on irrigation system installation, resulting in delays in planting. The unfavourable

Geopolitical situation also interrupted the smooth flow of operations and affected supply chain processes. This partly contributed to the delays in completion of projects. Lastly, our unfavourable financial position resulted in the deferment of some projects that are aimed at enhancing performance and productivity, namely the Pump Station 23 Upgrade Project.

Livestock and game

For the department to meet its targets, we have to reduce the game numbers, which are competing with the livestock for nutrition. This affects the conception rate and the number of cattle we breed yearly as we have to reduce the breeding here size to accommodate the increase in game numbers. We then need to mechanically clear the bush on the farm to counter the destabilisation of the health status of the veld. The proportion of trees to grass is high, yet cattle are grazers, not browsers, hence having a mulching machine, which opens the rangeland to have more grass compared to trees. A mulching machine to reduce bush encroachment at a high rate since we currently chemically control alien invasive plant species but at a slow rate. The mulching machine can covered to the same transfer of the same t

er more ground at a faster rate. This will increase the carrying capacity of the farm

The capex budget for 2023/24 includes the installation of a solar-powered Borehole for the Mathangeni section. This will provide the section with reliable water because the turbine that is currently supplying water is old, with spare parts now difficult to source



The ranch sits on about 19 000 ha, and rears about 2 000 head of cattle. The total number of game is about 18 400 head. The Red Brangus and Nguni are our main breeds. The feedlot gets its stock from two sources: cows that are culled from the ranch and another set that comes from private farmers and individual farmers from Swazi Nation Land in the fence line communities or elsewhere in the

country. The ranch covers the maintenance of biodiversity, custodianship, land stewardship, and a buffer zone for sugar fields. Sand River dam, which is a Ramsar site, and home to several water birds, is on the farm. Annually, we host ornithologists bird lovers, who view birds on the dam edge.


In 2022/23 we had our first livestock auction in September, and it was a success. We received 15% more revenue than normal sales. Furthermore, at the butcheries, we changed the operating times and rebranded the image of the butcheries. This improved sales as we were able to meet our budget for the year 2022/23.

One of our main challenges was the poor conception rate due to poor nutrition as a result of the ban on hunting of game. The ban on importation of cattle from South Africa is compromising the genetic make-up of our Brangus breed because we are unable to bring in new bulls.

Factories



What a challenging season for our factories, which had both started production on the same day but finished the cane more than 11 weeks beyond the original 30-week plan. The season was characterised by above-normal winter and summer rains, which caused extended stretches of slow crushing. This was compounded by two waves of cane cutters' strikes and national stay aways between September and November 2022, all culminating in the extension of the crushing season by an additional ten days of production time.

Soon after the latter cane cutters' strike, the summer rains came in abundance with their adverse operational effects, disrupting milling activities from week 28 to the end of the season. The Simunve factory crushed for 39 weeks and then

waited as standby, while the Mhlume factory continued to crush until 8 February 2023, ending what became a record 41-week season.

Under these conditions, two negative and material conditions permeated our milling operations for 2022/23:

Reduced sugar recoveries: deliveries to the mills were slow and constantly interrupted, with the lead indicator being high burn-to-crush hours. At the same time, the mills had to process cane from storm-damaged fields (see natural capital agriculture). Consequently, sugar recoveries were adversely affected.

High boiler fuel costs: Wet harvesting activities meant cane deliveries to the mills were slow and often interrupted, which is highly inefficient for

sugar mills. Supplementary boiler fuels thus had to be procured in an environment where geopolitical inflation exacerbated the cost.

Cane crushed was 154 590 tonnes (5%) higher than for the 2021/22 season, with new cane area available for harvest.

We have continued with our strategic initiative to increase the capacity of the factories by adding two new A-centrifugal machines during the off-crop period. The improved capacity of the plants will enable us to sustain higher equipment efficiencies and improve the sugar throughput. Boiler 6 at the Mhlume factory received a new economiser, the performance of which will be assessed in the 2023/24 season.

Outlook

The future looks sustainable for the business. We are developing the necessary skills at both technical and management levels. Improving the plant performance by adding new equipment is key to our Simama 20-25 strategy, in which sugar volumes are maximised, while costs are minimised. In this regard, our efforts at continuously improving downtime and overall recoveries in our mills will continue to receive maximum focus. Apart from the 2022/23 weather-induced inefficiencies, our factories continue to perform exceptionally well compared to the peer group in the region.

Initiatives planned for 2023/24 include:

- Identification of a new colour-removal chemical to improve sugar quality.
- New pipework will be installed at the mud filters station to improve the filtration of mud.
- A E26 million capital provision has been approved for the Simunye mill to acquire a new mud-belt filter that uses new technology.

Our factories continue to perform very well in comparison with their 27 peers in Southern Africa. This year we have made some efficiency improvements as part of the factory upgrades, in line with our strategy.



5.5 MANUFACTURED CAPITAL - continued

Distillery



Although RES is fundamentally a sugar company, ethyl alcohol is becoming a viable alternative revenue stream. Our ethanol division has grown from strength to strength to become a major player in the international ethanol market, without losing its regional relevance. Our plant is engineered to produce superior quality extra neutral ethyl alcohol for high value application.

The annual molasses quantity, on average, has been revolving around 130 000 tonnes for the past 2-3 years, which, per the RES Business Plan, should have been 160 000 tonnes by now. This leaves the distillery offline for 3-4 months in a year.

A key milestone in 2022/23 was the modification and upgrade of our old 40 KL/day capacity distillation plant, which now has new multi-pressure vacuum technology and a new capacity of 69 KL/day. Integrated into it is an anhydrous alcohol plant

of 55 KL/day. The result of this is a major saving in energy costs as the new plant now operates at 2.6kg/litre steam consumption, compared to 5.4 kg/litre previously.

In the 2022/23 season, the distillery produced 32.5 million litres from 137 912 metric tonnes of molasses supplied by our two sugar mills. The alcohol recovery was 235.8 litres per metric tonne of molasses, compared to a budget of 245 litres per metric tonne and a 2021/22 actual of 238.6 litres per metric tonne. The lower alcohol recovery was due to the season's poor quality molasses and frequent power failures, leading to losses and re-processing affecting alcohol yields in fermenters.

For 2023/24 the distillery is targeting to produce 32.7 million litres from 133 379 metric tonnes of molasses at the conversion rate of 245 litres per metric tonne of molasses.

Mananga Sugar Packers

A 50-50 partnership between RES Corporation and RCL Foods, Mananga Sugar Packers (MSP) specializes in pre-packing white, brown, castor and icing sugar in a state-of-the-art packaging facility in Mhlume, located inside the sugar mill premises. MSP employs approximately 190 employees, including seasonal and casual employees, who run the 24hrs/day operation.

MSP's business model begins from sourcing sugar from the Eswatini Sugar Association, and pre-packing both brown and refined sugar into different brands.

The catalogue of brands that MSP sells is wide with various house and retail brands. Pack sizes range from 500g to 25kg for both refined and brown sugar.

Production

During the year under review, Mananga Sugar Packers did not perform as planned due to the industry-wide unavailability of sugar during the financial year. As at the end of March 2023 MSP had packed 103 601 tonnes, compared to 117 939 tonnes in the previous year.

Sales and Marketing

As at the end of March 2023, MSP had sold 100 590 tonnes compared to 117 037 tonnes in the previous year.

Property Services provides housing, security, and various municipal services such as wastewater treatment, grounds maintenance, and solid waste removal - including management of the only engineered landfill in the Region.

Housing

During the year under review, we continued providing housing to employees and to third-party tenants, especially those providing services to the company. The average occupancy level for the vear was 91% of the 5 749 commissioned buildings.

Infrastructure Maintenance

Due to the age of the buildings, some built as far back as the 1950s, regular maintenance is required to keep the stock in as good and habitable condition as possible. This year we managed to continue our planned maintenance program, which seeks to reduce the maintenance backlog from about 1 200 to 900 units. Maintenance usually suffers from underfunding globally due to many pressing business requirements. Most maintenance works are outsourced and managed via contracts per agreed Service Level Agreements (SLAs).





Crime generally rose due to sociopolitical developments, rising poverty, and arson attacks. A study was undertaken to benchmark with similar establishments. Security gaps were identified, and a plan was adopted to introduce additional security measures to mitigate the rising criminal activity. The new security arrangements resulted in improved turn-around times for fire control being drastically reduced from 30 minutes to just under 10 minutes to control spread and limit damage to cane.


Objectives & Targets

Our goals and targets for the year 2022/23 were:

- Review of the security offering in response to socio-political developments
- Integration of former IYSIS infrastructure into RES master data and management of this additional infrastructure
- Replacement of asbestos roof coverings in response to environmental concerns, especially with climate change causing more storm damages
- Improve cost control by achieving a surplus of E5 million and contribute to Simama 20-25











Unfortunately we were forced to suspend the asbestos roof removal project due to a bad busines performance during the vear.

Achievements


During the year under review, we managed to achieve the following:

- Incorporation of an additional 120 housing units into master data after the acquisition of former IYSIS (now Livestock and Game department) into RES.
- Deploying a security strategy to close identified security gaps related to:
 - The increasing theft of copper at pump stations, as well as theft of fruit from the citrus business.
 - Improving firefighting and response in the wake of unrelenting arson attacks

- Improving social relations with our fence line communities in order to derive better safety and security outcomes, which are imperative for the sustainability of the communities and the business.
- Review of some of the outsourced services for alignment with cost control, in support of the Simama 20-25 drive. As a result, we achieved a E10 million surplus against a budgeted surplus of E7 million through a combination of suspension of some not very pressing initiatives, as well as continuation of insourcing some trades, e.g., buying paint and only outsourcing labour, and doing inhouse flyscreen fabrication instead of outsourcing.

Our challenges to achieving our goals and targets were:

- Low-lying houses are prone to flooding in extreme wet weather which is becoming quite regular.
- As a result of cost challenges in the year, a capital budget earmarked for the replacement of a high percentage of houses still under asbestos roof sheets had to be suspended.
- Lack of funding for upgrading of wastewater treatment facilities to address effluent compliance with legislation. The investment required for this is very heavy and currently prohibitive.





We put a substantial amount of effort into waste management as part of our activities aimed at improving sustainability of the business and the environment.

Communication





The corporate communication office is responsible for information dissemination in the business. We have various internal and external platforms for this. Internal channels include face-to-face meetings, lunches with the managing director, the managing director's walkabout, management brief, memos, news boards, digital billboards, podcasts and Chumana – a bulk SMS channel.

To increase our footprint with external audiences and to building our brand, RES subscribes to Facebook and LinkedIn. The RES Website is also part of the means to engage with our external stakeholders.

During the reporting period, we implemented a news bulletin platform (podcast style) which was initially audio bulletins of current activities and initiatives taking place in the business. We now have improved this platform to include video, which

will be published through screens that are strategically placed around the business, as well as on WhatsApp.

A challenge during 2022/23 was the disengagement among communication champions, now advocates, created a gap. We have relaunched the communication champion system, with communication advocates, who have been retrained to ensure more consistent content sharing and more efficient updating of the newsboard system.



Procurement



During the reporting period we embarked on a couple of projects, which included the launch of an electronic auction system. The system was designed in such a way that internal and external bidders would be able to view items and offer bids. The adjudication of the bids is automatic, and it is designed to handle allocation of winning bids by the highest offer price or of allocation winning bids through random selection. The random selection is used when items on offer are sold at a fixed price, such as the redundant boiler or evaporator tubes.

Another project, which was launched was the deployment of an electronic platform for issuing requests for proposal documents. The platform makes it easier for tenderers to receive documents through cloud link, instead of sending documents through email, which has size limitations.

We also reviewed the Tender Policy and the Terms and conditions of purchase for goods and services.

The supplier application webpage was improved to include a document compliance checklist to assist potential suppliers to cross-check the completeness of their applications in terms of the required documents to be attached. The vendor assessment criteria were also published to assist potential suppliers to understand how their applications will be assessed.

1% of the total spend was saved through negotiations in tender pre-award, annual contract reviews and spot purchases.

Goals and targets for 2022/23

The vendor master was cleaned up to remove suppliers who have not been active for more than 12

months. Notices were sent to the remaining active vendors to update their registration documents in preparation for the periodic vendor assessment which will be in two folds. First assessment and classification exercise will be conducted off-site using the standard vendor evaluation criteria and supplier spend analysis. The second part will be on-site assessment of all vendors who have been classified as critical based on the off-site exercise.

RES provides extension service to all sugarcane growers, paying particular attention to small and medium scale growers, as well as farm management services to growers who, for various reasons, cannot manage the farms on their own. We also assist with pump maintenance services and provide a transport subsidy to long-distance growers, who are mainly in Malkerns and Sidvokodvo.

Specific challenges during the reporting period:

- · Climate change challenges that come with storms, hailstorms, frost damage on cane, and new pests and diseases.
- · Financial challenges in some farmer companies, which forced some growers to stop irrigating when the power supply was suspended. Some growers were unable to pay suppliers and employees' wages.
- · Social conflicts among growers, which resulted in stopping critical operations on the farms.

The 2023/24 plan includes the development of a turnaround strategy for Umbane (Pty) Ltd, Hhohho and Kusile.

6.1 GOVERNANCE OVERVIEW

During the year under review, the Board executed all its scheduled activities as set out in the Board Charter.

The RES Board has a unitary structure, comprising 11 non-executive directors (including one elected exclusively by small shareholders) and one executive director. The directors are not regarded as independent within the definition of King IV, as they are all shareholder appointees. We are of the opinion that this does not affect the Board's independence, as all non-executive directors exercise independent judgment in all Board deliberations in accordance with policies concerning directors' conduct. These policies are aimed at ensuring that directors perform their fiduciary duties diligently in the best interests of the Corporation and its stakeholders.

We review and enhance our governance structures and practices on an ongoing basis. Our aim is to incorporate recommendations on good governance that suit our circumstances and contribute to delivering sustainable growth in the interest of all stakeholders.

Corporate governance is the responsibility of both the Board and executive management, with a culture of good governance embedded throughout the organisation. The ultimate responsibility for good corporate governance rests with the Board of Directors. The Board endorses the principles of fairness, responsibility, transparency, and accountability contained in the King Reports. At RES we aim at demonstrating how our practices are in accordance with these principles and contribute to the achievement of good governance outcomes.

In circumstances where application of any of the recommended King IV principles has been found to be unsuitable for the Corporation's circumstances, we put other controls in place, where necessary, to ensure good governance.

The Board follows a stakeholder-inclusive approach in its decision-making processes, having due regard to the interests of shareholders and other stakeholders. Concern for sustainability as a business imperative guides us in the formulation of our strategy.

The Policy on Powers Reserved for the Board of Directors and Delegated Authority has been maintained unchanged, and the Board has continued to delegate certain responsibilities on an ad hoc basis.

Board responsibilities

The Board functions in terms of a Board Charter, which defines the Board's continued objective of providing ethical business leadership. The Charter regulates among others, the role of the Board as the custodian of corporate governance, the fiduciary duties and responsibilities of the Board and individual directors towards the Corporation.

We do not implement formal evaluation of the performance of Board members. However, performance is monitored and tracked through annual work plans formulated in accordance with the Board charter and subcommittee terms of reference. The Board is satisfied that during the year under review, it effectively carried out its responsibilities in accordance with the Board Charter.

The Board meets quarterly, and, when necessary, special meetings are convened from time to time. Members of the Executive Committee attend Board meetings, when relevant matters are discussed, to ensure comprehensive reporting to directors.

Management provides regular briefings on material issues to the Board. This enables the Board to monitor operational and financial performance of the business, key risk matters and major Corporation initiatives on an ongoing basis.

Mr Sylva Okolieaboh has replaced Mr Idris Ahmed who has retired as board member with effect from March 2023. We welcome Mr Okolieaboh on the Board and wish him a productive and pleasant period on the Board.

Board Induction and Development

RES is committed to the continuing development of its directors and to supporting them in building on their expertise and developing a more detailed understanding of their responsibilities.

Newly appointed directors undergo an induction programme to facilitate their understanding of the sugar industry, business environment and markets in which the company operates, as well as information on directors' roles and responsibilities in terms of regulatory requirements and best practice (King Reports on Corporate Governance). This programme also includes information on Group structure and long term business strategy, financial and non-financial performance, reciprocal expectations, corporate policies and procedures, and familiarisation through site visits and consultation with senior management.

Open dialogue is encouraged between individual Board members and the MD and other members of the management team to enable directors to gain a better understanding of the Corporation and its operations.

Directors receive briefings on new legal developments and changes in the risk and the general business environment on an ongoing basis.

Internal Audit

RES manages significant risks affecting the Group and the business environment in which it operates by maintaining internal controls and systems designed to provide reasonable assurance against material misstatement or loss.

The internal audit function monitors the system of internal control and reports its findings and recommendations to management and the Audit Committee. The purpose, authority and responsibility of the Internal Audit function are formally defined in the Board-approved Internal Audit Charter. The annual audit plan is based on an assessment of risk areas identified by internal audit in liaison with management as well as areas highlighted by the Audit Committee.

The work undertaken during the year included reviews of high risk areas which include:

- Fixed assets
- Procure to pay
- Sugar receiving
- Warehouse and dispatch
- Ethanol marketing & logistics
- Cane production, harvesting and haulage operations
- Stores operations.

Fraud awareness and prevention initiatives continued.

Shareholder Engagement

The Corporation is committed to communicating and engaging with shareholders, and pursues this interaction in line with the King VI principles on stakeholder management. Shareholders are provided with an update on the Corporation's performance at the Annual General Meeting at which shareholders have the opportunity to ask questions.

The Corporation also undertakes proactive engagement with institutional shareholders on a continuous basis and we employ a variety of both formal and informal engagement processes to ensure alignment with the interests of shareholders and to enable an understanding of their views.

Ethics

Our fundamental policy of conducting business with honesty, integrity and in accordance with the highest legal and ethical standards, is central to our operations. The Board's Code of Conduct guides the ethical and behavioural standards to which the Exco adheres in carrying out its duties

and responsibilities in a manner that is consistent with effective corporate governance practices.

RES records its pledge to promote and enforce ethical business practices and standards throughout the Corporation in its approved Code of Ethics, its guide in day-to-day decision-making processes. All employees are expected to comply with the principles and ethical standards defined in the Code as well as with various other policies and procedures which support it. These include, among others, policies on conflict of interest, "whistle-blowing" and fraud prevention.

The Corporation does not engage in or accept or condone any illegal acts in the conduct of its business and operates a "whistle-blowing" line managed by an independent firm of auditors.

This line provides an impartial facility for all stakeholders to anonymously report fraud, statutory malpractice and other crimes, unsafe behaviours, deviations from procurement policies or any other deviation from ethical conduct. All matters received via the line are investigated, appropriately resolved and reported upon to the Risk, Social and Ethics Committee.

Controls

The Corporation conducts a number of reviews to determine the effectiveness of its internal controls, procedures and systems. Reviews undertaken during the year relate to:

- Information management environment
- Reliability and integrity of financial and operating information
- Safeguarding of assets, including fraud prevention, and effective use of the Corporation's resources

No material internal control weaknesses were noted from these reviews. Corrective action was taken as and when control deficiencies or opportunities for improvement in the systems were identified. Based on these reviews, there is reasonable assurance that an effective system of internal controls and risk management is in place.

6.4 OUR EXECUTIVE MANAGEMENT

On the Executive level, key management decisions are made by the Managing Director (MD), who in terms of the Policy on Matters Reserved for the Board and Delegated Powers has been delegated authority on a wide range of matters in relation to financial, strategic, operational, governance, risk and other functional issues.

The MD has in turn delegated authority to senior management committees (which include Exco, the Tender Committee, the Risk Management Executive Committee and the IT Steering Committee) and individual members of the management team who assist the MD in guiding and controlling the overall direction of the business and monitoring business performance. Where necessary, ad hoc management committees are put in place to focus on and monitor issues of strategic importance to the Corporation. The MD, however, remains accountable to the Board for all authority delegated to him.

The senior management committees and/or senior managers act to:

- Translate and implement the Corporation's strategic direction in an operational plan,
- Monitor its successful implementation and the achievement of performance in accordance with agreed-upon budgets and timelines,
- Oversee human development and succession planning in order to develop future leaders for RES.
- Allocate human resources throughout the Corporation, and
- Ensure that appropriate IT systems exist to support business operations and to provide useful management information to facilitate effective decision-making.

Regular management meetings, including monthly Exco meetings, are conducted to monitor these aspects in order to address day-to-day operational challenges, strategic business issues, sustainability and strategic project developments.

ABRIDGED DIRECTORS' REPORT

FOR THE YEAR ENDED 31 MARCH 2023

The Directors have pleasure in presenting their adbridged report together with the abridged consolidated financial statements for the year ended 31 March 2023.

General review of operations

The Group's principal activities are the growing and milling of sugar cane, the manufacture of sugar, and the manufacture of ethanol from molasses. The results of operations are disclosed in the attached abridged consolidated financial statements. Full disclosures are available in the consolidated and separate financial statements on the RES website.

The financial performance for the financial year ended 31 March 2023 reflects trade under adverse climatic conditions and disruptions with unprecedented winter rains that forced the extension of the season into an un-ideal rainy season. Combined with cane cutter strikes, the crushing season extended into early February 2023. Despite the mills processing higher cane, sugar volume was 1% lower than for 31 March 2022, due to lower sugar recoveries. The recoveries were affected by the longer burn-to-crush times as a result of wet harvesting activities.

Operating costs were significantly higher, due to the inherent inefficiency embedded in harvesting and crushing under the wet winter and summer conditions. The geopolitical impact of cost inflation due to the Russia/Ukraine conflict was present throughout the financial year, exacerbating an already difficult trading period. Cost containment measures were initiated for both operating and capital expenditures.

In March 2023 the company acquired a 35% share interest in Enviro Applied Products (Proprietary) Limited at a price of E28.471 million. Enviro Applied Products is in the business of producing and selling liquid fertilizer and is located within the Lowveld of Eswatini.

As at the date of these financial statements, extension of lease agreements for land leased from Tibiyo TakaNgwane were at an advanced stage and await signature. Subsequent to year end, the lease agreements were all signed for an initial lease period of 25 years with an option for renewal for another 25 years.

Dividends

The following dividends have been declared:

- A first interim dividend for the year ended 31 March 2023 of 53.5 cents (2022 125.0 cents) per share which was paid in November 2022;
- During the current financial there was no second or final dividend declared for the year ended 31 March 2023 (2022 67.9 cents) per share.
